TERMS OF WARRANTY

The following points would be covered in Life Time Warranty Product:

- 1) The Motor is covered in LTW product.
- 2) The rotor is covered in LTW product
- 3) The main circuit of the Chimney (PCB) would be covered in LTW product.
- 4) Visit made by the company technician for repair of the items covered under warranty would free.

If any problem occurs to the above mentioned parts, it would be repaired or replaced as the decision by the company.

The Following points would not be covered in the Life Time warranty:

- 1) The Glass / Plastic / Charcoal Filters and metal body of the Chimney are not covered in LTW scheme.
- 2) The electrical Bulbs are not covered in LTW scheme.
- 3)The Alluminium wire cassette filter is not covered in LTW scheme. (It has to be cleaned and maintained by regularly by customer)
- 4) However routine maintenance viats / or vista for replacing parts is not covered in LTW scheme, will be on chargable basis.
- 5) The company undertakes no liability in the matter of consequential loss and / or damages caused to the customer or third part due to failure / malfunction of the machine. The company obligation under this warranty shall be limited to repairing or replacing the defective parts.
- 6) The warranty becomes null and void in following cases but not limited to:
 - A) Installation / Service / Repairs / Modification is carried out by person other than those authorised by company.
 - B) Failure due to user's inaction towards minor maintenance such as cleaning filters.
 - C) Change of Ownership.
 - D) Failure due to Electric Power supply.
 - E) Damage resulting to the unit due to operation in an abnormally corrosive alkaline / acidic atmosphere, and / or use of harmful chemicals.
 - F) Failure due to misuse / negligence, and / or acts of God.
- 7) For units installed beyond the Municipal limits of the area of operation of the authorised service center of the company or in areas where no service center is present, all expenses incurred in transporting the machine or parts to and from the nearest service center as well as expenses incurred towards loading unloading etc. will be borne by the customer and will be payable in advance.
- 8) The decision of the company with regards to the settlement of all claims under this warranty shall be final. courts in Mumbai shall have exclusively jurisdiction in the event of any dispute.
